NOTICE OF RACE

1. RULES

1.1

The regatta will be governed by the rules as defined in *The Racing Rules of Sailing*, the rules set out by the Offshore Racing Congress and Montenegrin Sailing Federation.

1.2

If there is a conflict between languages the English text will take precedence.

2. ADVERTISING

2.1

Boats may be required to display advertising chosen and supplied by the organizing authority.

3. ELIGIBILITY AND ENTRY

3.1

The regatta is open to all boats in possession of ORC Club or ORC International certificate and the MNE Cruisers classes.

4. FEES

4.1

Required fees are as follows:

CLASS	FEE
CRUISERS	5 euros per crew member
ORC	5 euros per crew member

5. SCHEDULE

5.1

Registration: 20th June 2020, Race start 12:00
09.00- 10.00 on the day of the regatta

Measurement and inspection:
Date and times to be allocated.

5.3

Date of racing: 20th June 2020

5.3

Number of races: 1 race

6. MEASUREMENTS

6.1

Any boat with an ORC Certificate shall produce it at Registration.

7. SAILING INSTRUCTIONS

7.1

The sailing instructions will be available on the day of the race at registration.

8. THE COURSES

8.1

The courses to be sailed will be given together with sailing instructions on the day of the race.

9. SUPPORT BOATS

9.1

Support boats shall be marked with a PMYC flag.

10. BERTHING

10.1

Boats shall be kept in their assigned places while they are in the marina.

11. HAUL-OUT RESTRICTIONS

11.1

Keelboats shall not be hauled out during the regatta except with and according to the terms of prior written permission of the race committee.

12. RADIO COMMUNICATION

12.1

Radio communication will be on VHF 72.

13. PRIZES

13.1

Prizes will be given as follows: The First and Second placed sailing boat in each class will receive an award. Special prize for the fastest boat on the course.

13.2

Awards will be presented at an awards ceremony at YC Porto Montenegro after the race has finished.

14. DISCLAIMER OF LIABILITY

14.1

Competitors participate in the regatta entirely at their own risk. See rule 4, Decision to Race.

14.2

The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

15. INSURANCE

15.1

Each participating boat shall be insured with valid third-party liability insurance.
